Regarding opening of Ekalavya Model Residential School (EMRS) in Pangi at Killar.


Sir,

I am directed to refer your letter No. Res. Commr-PNG-EDN-15/2010-2884 dated 29.10.2015 (copy enclosed for ready reference) on the subject cited above and to inform you that Govt. of India, Ministry of Tribal Affairs, New Delhi has approved Rs. 16.00 crore for construction of Ekalavya Model Residential School (EMRS) at Village Ghangeet Gram Panchayat Karyas, Tehsil Pangi as per revenue paper submitted vide your letter under reference. Ministry has also released Rs. 5.00 Crore during 2018-19 as 1st installment for construction of EMRS Pangi at Killar which will be released to you very shortly.

In view of above, necessary steps for setting up EMRS at Village Ghangeet Gram Panchayat Karyas as per the norms fixed in the revised guidelines dated 28.09.2010 (copy enclosed) issued by the Ministry of Tribal Affairs, are to be taken up at ITDP level. Since, EMRS will be the Asset of Tribal Development Department, the transfer of land should be in the name of EMRS Pangi under control of Tribal Development Department and Project Officer, ITDP Pangi at Killar will be the applicant for transfer of land and preparation of FCA case, if required.

It is therefore, requested to kindly take appropriate necessary action immediately for (i) transfer the proposed land in the name of EMRS Pangi under control of Tribal Development Department, (ii) to prepare the FCA papers, if required and (iii) to request the PWD authorities to prepare the estimate/drawings for construction of EMRS as per requirement mentioned in the revised guidelines of EMRS issued by the Ministry of Tribal Affairs for setting of EMRS with the capacity of 480 students (Class VI to XII) so that construction work could be started and school could be made functional as soon as possible.
